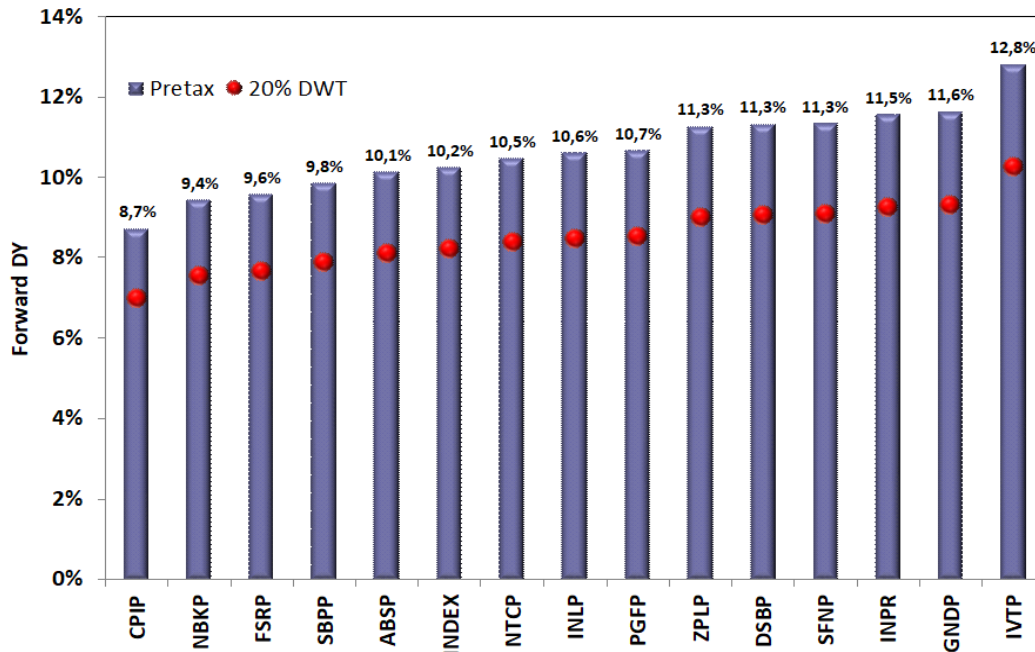

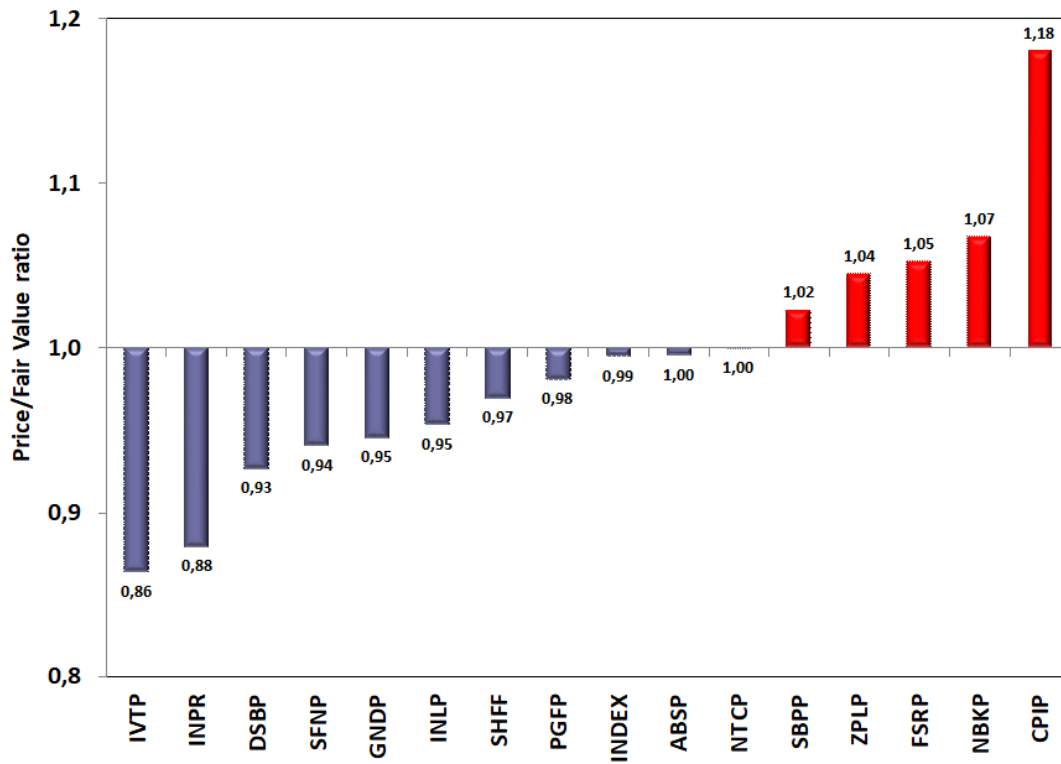


Figure 1 - Price-to-fair value ranking

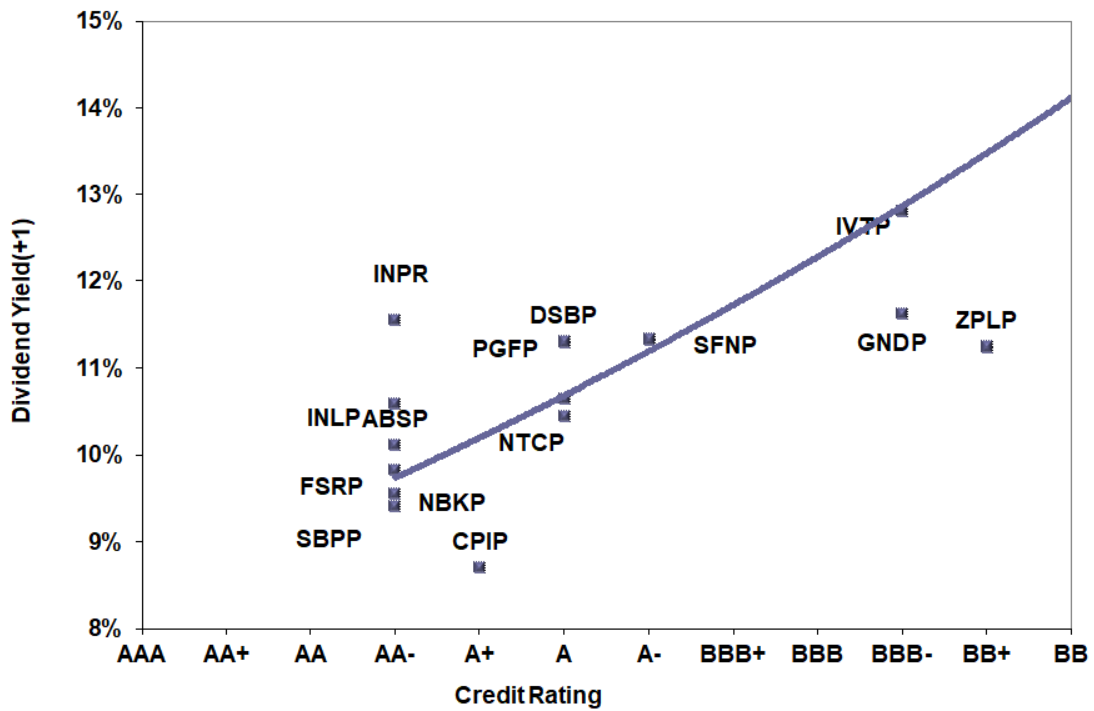


Figure 2 - Yield and Credit rating

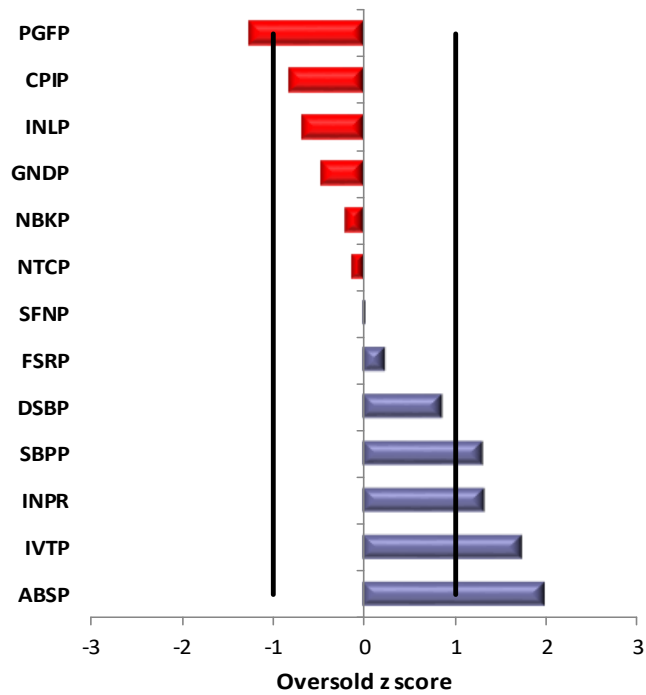
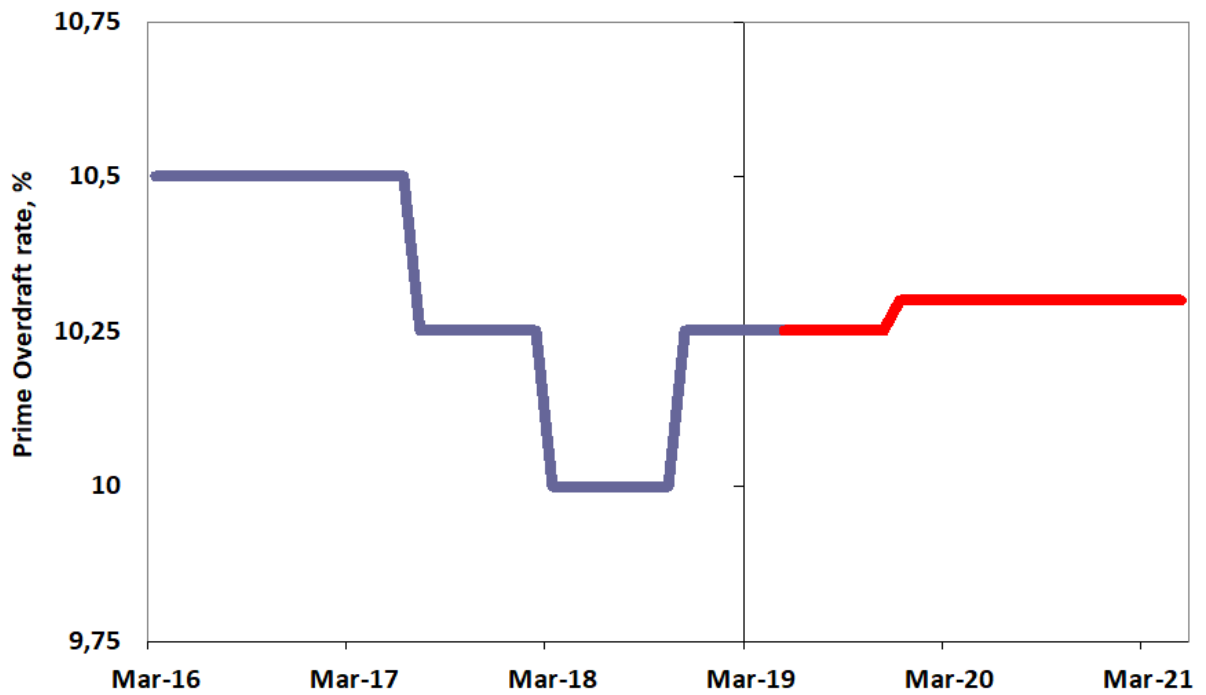


Figure 3 - Overbought/oversold indicator
